

### The Law

You need to make sure your child attends school regularly and on time. You will be **breaking the law** if you do not do this and there are no good reasons for your child missing school.

### Help and Support

If you need help with attendance you must **talk to the school about it as soon as possible.**

Sometimes, school may need to involve other services to help. The School and Local Authority **want to help you if you have a problem.** If attendance does not get better or you do not accept help and support offered, the Council may have to begin enforcement action.

## Attendance Information

## **Attending school is very important**

Your child must attend school every day. Children who are regularly absent from school miss opportunities which can affect their life-long chances. If you have any concerns about your child's attendance contact school, so we can work together to improve the situation.

### **Lateness**

School starts at 8:55 am.



Your child will receive a late mark if they arrive after this time. The register closes at 9:15 am. If your child arrives after this time, they will receive an unauthorised absence mark.

### **If Your Child Is Absent You MUST:**

- Contact school on each day of absence and provide reasons for absence T: 0191-3730355
- Keep school informed on a regular basis if your child is absent for a long period.
- Follow Coronavirus procedures – to ensure students, staff and our school community can stay safe. Your child will not be penalised for isolating.

### **Failure to do these things may result in your child's absences being unauthorised**

Unauthorised absences will be recorded on the register when there is no valid reason given for absences, a holiday not approved by the school, lateness after the register closes or illness without medical evidence.

## **Medical Appointments**



If it is possible, any appointment should be made out of school time. If this is not possible, your child should miss the minimum amount of school time necessary. **If your child is well enough to go back to school following the appointment, they should do so.**

### **Medical Evidence**

You will be asked for medical evidence and will need to provide copies of GP appointment cards or letters, medication details or other relevant information.

### **Leave of Absence**

Please request an **application form** from school. Consider quarantine requirements and FCO advice when booking travel. Unauthorised leave may result in a Fixed Penalty Notice (fine) or court prosecution. *A leave of absence for a holiday will not usually be authorised.*

### **Persistent Absence**

If your child's attendance falls to 90% or below, this is considered, by Government to be persistent absence. Where attendance falls below 90% and there are unauthorised absences, this may result in a referral to the Local Authority for enforcement Action.
